Blue Preferred PPO: 8 Bronze, 4 Silver, 2 Gold

- Network: Blue Preferred PPO[™] (PPO)
- Approximately 65 hospitals, 11,119 providers*
- Choice of doctors and hospitals throughout the state
- Traditionally has higher monthly premiums than POS plans

Blue Focus POS: 4 Bronze, 3 Silver, 2 Gold

- Network: Blue Focus POS[™] (BLC)
- Approximately 12 hospitals, 4,027 providers*
- Point of Service product
- May have lower premium cost than PPO plans

- Coverage for cleanings, preventive services and much more
- Preventive dental services deductible waived
- New lower-cost 1c family plan offered

Prescription and Pharmacy
